

PARTICIPATE AT YOUR OWN RISK

- 1. All Participants must have a signed liability waiver on file with Insanity Skate Park. Participants under the age of 19 must have a parent or legal guardian sign the waiver in the presence of a notary public. You must be a least six (6) years of age to skate or bike at Insanity Skate Park.
- 2. You must skate or bike safely and remain in control at all times. All Participants are responsible for avoiding collision with others.
- 3. BMX bikes must be inspected by Insanity Staff before being admitted onto the skating/biking area. No metal pedals, metal bar ends, or metal pegs (unless covered by a plastic sleeve) are allowed. No exceptions.
- 4. Proper protective gear must be worn at all times in the skating/biking area. At a minimum, Participants must wear a helmet, knee pads and elbow pads designed for safety. It is highly recommended that wrist guards and gloves also be worn.
- 5. Non-related gear and clothing is not allowed in the skating/biking area. Shirts and shoes must be worn at all times.
- 6. Other than for special events sanctioned by Insanity Skate Park, contests or other competitions are prohibited.
- 7. No food, drink or chewing gum may be brought into the skating/biking area. The use of tobacco products of any type are prohibited at all locations within Insanity Skate Park. No drugs, whether over-the-counter or prescription, are allowed at any time, and may result in immediate expulsion from Insanity Skate Park.
- 8. Fighting, profanity or any other disruptive behavior is strictly prohibited. Staff members have the discretion to identify unwarranted conduct as necessary to ensure that Participants, attendees, and Staff have an enjoyable park experience.
- 9. Insanity Skate Park reserves the right to cancel any membership at any time or eject anyone for any reason. No refunds allowed.
- 10. Participants are responsible for arranging for their own pick-up and/or transportation from Insanity Skate Park property upon closure of the park, whether for inclement weather, normal park hours, or early closure for any reason.
- 11. Have fun, be courteous, obey all Insanity Staff Members, and participate safely.

INSANITY SKATE PARK LIABILITY WAIVER AND RELEASE

THIS AGREEMENT RELATES TO INSANITY SKATE, INC., dba INSANITY SKATE PARK, located at 100 Skate Park Drive, Madison, Alabama 35758

THIS AGREEMENT CONSTITUTES AN EXPRESS CONTRACTUAL ASSUMPTION OF ALL RISKS, WAIVER OF AND RELEASE FROM ALL LIABILITY, INCLUDING BUT NOT LIMITED TO NEGLIGENCE, AND AN INDEMNITY FOR ALL THIRD PARTY CLAIMS.

We know that skateboarding, in-line skating, BMX biking, and other forms of skating and biking are inherently dangerous sports and activities in which we choose to voluntarily participate at our own risk. We are aware that the usual risks, hazards and dangers of personal injury, death and disability or property damage and loss (collectively "damages"), necessarily increase when using ramps, curbs, steps, half pipes, inclines or declines, bowls or an other structure and device. We know that the risks, hazards and dangers include, but are not limited to, uncontrollable boards or bikes, falling, jumping, landing, performing tricks, colliding with other users, staff, media personnel and spectators. We also understand that these risks, hazards and dangers are further increased when other persons, whether or not of the same level of experience or skill, are present at the same time and are using the same facilities. (All of the above defined activities are collectively referred to throughout this Agreement as "Hazardous Activities".)

By executing this agreement, it is our intention to relieve Insanity Skate Park of any duty to us and we do assume the entire risk of any Damages which might occur during or as a result of my use of or presence at Insanity Skate Park ("the Park"). By this agreement I also release, discharge and absolve Insanity Skate Park from any and all liability for any active or passive negligence whatsoever by the Park and waive and relinquish any claim or cause of action against the Park for any loss, claim, damage, personal injury, disability, death, medical, and any other type of expense or property damage or loss caused by any negligence, or any other act or failure to act of Insanity Skate Park, and promise not to sue or exercise any legal right to seek damages from Insanity Skate Park. This agreement will remain in full force and effect until revoked in writing by all of the persons signing it, after which the Participant will no longer have the rights to use the facilities of Insanity Skate Park.

In consideration of utilizing Insanity Skate Park, we agree as follows:

- 1. As to my participation in any activity including, but not limited to, the Hazardous Activities and as to any and all liability for the Damages which I may suffer or incur due to any cause whatsoever, while in the interior or exterior of the premises of the Park, we hereby agree:
 - a. To waive any and all claims for Damages that I may have against Insanity Skate Park, Insanity Skate Inc., its managers, employees, officers, directors, shareholders, investors, associates, agents, contractors, volunteers, sponsors, vendors, or exhibitors or any other person or company in any way associated with it;
 - b. To release Insanity Skate Park from any and all liability for the Damages that I may suffer or incur, or that my next of kin may suffer as a result of my participation in any activity, including but not limited to, Hazardous Activities while at the Park; and
 - c. To hold harmless and indemnify Insanity Skate Park and all associated with Insanity Skate Park from any and all liability for the Damages to any third party resulting from my participation in any activity, including but not limited to, the Hazardous Activates while at the Park.
- 2. We understand that the Staff of Insanity Skate Park are expected to enforce high standards of Participant conduct and behavior to assure that other Participants, attendees, and Staff may enjoy the skate park without interference or distraction from unruly, noisy, or otherwise inconsiderate Participants. Staff Members have the discretion to identify unspecified misconduct as warranted. The undersigned hereby agree to abide by the verbal (or otherwise specified) standards of conduct as defined by Insanity Skate Park Staff Members. Violations of these standards may result in disciplinary consequences, up to and including permanent expulsion from the premises, with no refund of any dues, memberships, and/or event fees.
- 3. The undersigned understand and agree that they are financially responsible for the Participant's destructive acts against Insanity Skate Park property and/or persons.
- 4. We understand and agree that Insanity Skate Park is not liable or responsible for the well-being, safety, parent contact, or transportation of any Participant(s) either during operating hours or once the park closes, whether closure is the result of inclement weather, normal business hours, or for any other reason.

INSANITY SKATE PARK LIABILITY WAIVER AND RELEASE

- 5. This waiver and release of liability and indemnification agreement (collectively referred to hereafter as "Waiver and Release") shall be effective and binding upon my heirs, next of kin, family, relatives, guardians, conservators, executors, administrators, trustees and assigns in the events of my injury, disability or death.
- 6. We have read, understand and agree to be bound by the Safety and Conduct Rules governing my behavior while using the Park. We understand that these rules are strictly enforced.

Any dispute, controversy or claim arising out of this Agreement or the interpretation of this Agreement shall be settled by arbitration in accordance with the Rules of the American Arbitration Association, except to the extent modified below. The place of arbitration shall be Huntsville, Alabama. The award of the arbitrator (the "Award") shall be final and binding upon the parties and judgment upon the award may be entered by any court of competent jurisdiction. The arbitrator shall be required to determine all issues in accordance with substantive law of the state of Alabama. The rules of evidence applicable to proceedings at law in the state of Alabama shall be applicable to the arbitration proceeding.

NOTICE: BY SIGNING THIS RELEASE AGREEMENT, THE UNDERSIGNED AGREE TO HAVE ANY CLAIM DECIDED BY NEUTRAL ARBITRATION AND GIVES UP THE RIGHT TO A JURY OR COURT TRIAL.

The undersigned understands that according to Alabama State Law under ACT# 2003-399, any person who participates/ assists in the activities conducted in a park or rink is responsible for all damages, injury, or death to self or other persons which result from these activities and that the Participant is legally responsible for all damages, injury, or death to self or others which results from these activities. Full statement of the Law is public.

The undersigned further AGREE that this Agreement is intended to be as broad and inclusive as is permitted by the law of the state of Alabama and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned certifies that he/she has no medical condition which would cause participation in activities at the Park to be potentially hazardous to his or her health. In addition, this Agreement shall constitute authorization for Park Staff, free of any liability whatsoever, to provide or cause to be provided such medical treatment to the undersigned as may be necessary or appropriate if any injury occurs while at the Park. I further authorize attending medical personnel to execute on my behalf any permission forms, consents, or other appropriate documents relating to medical attention and to act on my behalf if I am not able or immediately available to do so.

The undersigned also authorizes Insanity Skate Park the royalty-free right to use (including copyright therein) and distribute all photographs and/or video(s) taken of the Participant while participating in activities at the Park for advertising or promotional purposes.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS AGREEMENT, and further agrees that no oral representations, statements, or inducements apart from this Agreement have been made by the Park or anyone else with regard to the subject matter of this Agreement.
